⁴ The November 10, 2015 release incorporates conceptual and statistical revisions to the provincial-territorial estimates of gross domestic product by industry for reference years 2007 to 2014. Users are advised to use caution in making comparisons between the 2002 to 2006 and 2007 to 2014 estimates.
