Families are defined within a household. A household consists of all persons who share the same address with no regards to other possible relationships between them.

The composition of a family is determined by the relationship between the residents of the same household. A family thus comprises of one or more persons in a household that can be linked to each other through marriage, parenthood or kinship. A household may consist of several families, but families can in reverse not have members from more than one household.

A family consists of one or more persons who live in the same registered address. A family consists of a single person or a couple with or without children. A family includes, in some cases all persons in a household, while other households divided into several families.

Registered partners are not calculated separately, and are calculated as married.

Families can be divided into three main types:

type of family:

For couples and singles a family can consist of one or more children (0-17 years) or youth living at home (18-24 years).

A family consists of no more than two generations. If three generations living together, it will be counted as two or more families.
