Treaty Indians are persons who belong to a First Nation or Indian band that signed a treaty with the Crown. Registered or Treaty Indians are sometimes also called Status Indians.

[68] 'Indigenous ancestry' refers to whether a person has ancestry associated with the Indigenous peoples of Canada that is First Nations (North American Indian) Mètis and/or Inuit. Aboriginal peoples (referred to here as Indigenous peoples) of Canada are defined in the Constitution Act 1982 Section 35 (2) as including the Indian Inuit and Mètis peoples of Canada. The term 'Aboriginal' has been replaced with the updated term of 'Indigenous' when referring to individuals who identify themselves as First Nations people Mètis and/or Inuit. Ancestry refers to the ethnic or cultural origins of the person's ancestors an ancestor being usually more distant than a grandparent. A person can have more than one ethnic or cultural origin.
