[1] Occupation (based on the National Occupational Classification [NOC] 2021 Version 1.0)

Occupation refers to the kind of work performed in a job, a job being all the tasks carried out by a particular worker to complete his or her duties. An occupation is a set of jobs that are sufficiently similar in work performed. Kind of work is described in terms of tasks, duties and responsibilities, often including factors such as materials processed or used, the industrial processes used, the equipment used, and the products or services provided. Occupations are generally homogeneous with respect to skill type and skill level. Occupation applies to the contribution of labour to that part of economic activity that is within the production boundary defined for the System of National Accounts.

[2] Gender

Gender refers to an individual's personal and social identity as a man, woman or non-binary person (a person who is not exclusively a man or a woman).

Gender includes the following concepts: gender identity, which refers to the gender that a person feels internally and individually

[3] Given that the non-binary population is small, data aggregation to a two-category gender variable is sometimes necessary to protect the confidentiality of responses provided. In these cases, individuals in the category “non-binary persons” are distributed into the other two gender categories and are denoted by the “+” symbol.

[4] Refers to the kind of work performed by persons aged 15 years and over as determined by their kind of work and the description of the main activities in their job. The occupation data are produced according to the National Occupational Classification [NOC] 2021 version 1.0.

[5] Place of work status

Place of work status refers to whether a person worked at home, worked outside Canada, had no fixed workplace address, or worked at a specific address (usual place of work).

[6] Industry (based on the North American Industry Classification System [NAICS] Canada 2017 Version 3.0) Industry refers to a generally homogeneous group of economic producing units, primarily engaged in a specific set of activities. An activity is a particular method of combining goods and services inputs, labour and capital to produce one or more goods and/or services (products). In most cases, the activities that define an industry are homogeneous with respect to the production processes used.

[7] Classification of respondents according to whether they worked at home, worked outside Canada, had no fixed workplace address or worked at a specific address (usual place of work).

[8] Refers to the general nature of the business carried out in the establishment where the person worked.

The industry data are produced according to the North American Industry Classification System (NAICS) Canada 2017 Version 3.0.
