The table is based on the Pay as You Earn (PAYE) register. Income from employment is the direct taxable earnings for the main economic activity as well as taxable allowances.

The main economic activity is the activity with the highest income each month.

Average income for each person is divided by economic activity, sex and region. ISAT95 is the Icelandic equivalent to NACE rev.1

classification. Average income is obtained by dividing the total annual income for main economic activity by the average number of employed persons.

The average number of employed persons is the average of the total number for each month.

Employed persons are wage earners and self employed.

This translates as annual income in main economic activity for an individual employed for the whole year.

The calculation of average income does not take different working hours per month into account and can thus not be interpreted as average income per man-year.
