Þá var greitt meðlag vegna menntunar til 122 ungra karla og 160 ungra kvenna. *Child maintenance is not a social security benefit although the S.S.I. serves as an intermediary for payments. Child maintenance due to education is included. Children supported through child maintenance were 696 on behalf of men and 12,975 on behalf of women. In addition 122 young men and 160 young women were supported because of education.*
